Sex & Relationships Education Policy

Description of School

Katherine Warington School is a mixed comprehensive school and will grow with additional year groups from its opening year with 180 Year 7 students in 2019 to 1150 students (boys and girls). Students come from all parts of Harpenden and many live in surrounding towns and villages. The local area is relatively affluent. However, a wide range of social backgrounds is represented in the school population. Very few students come from an ethnic minority background and few languages other than English are spoken at home. On entry the overall abilities of the students are above national norms and relatively few students have Educational Health Care Plans (EHCP).

Aims

- To help students understand biological facts, which will be presented in an objective, balanced and sensitive manner.
- To encourage students to appreciate the value of a stable family life, loving commitment to a partner and the responsibilities of parenthood. To also recognise that many people lead fulfilling lives as single people.
- To encourage students to recognise the physical, emotional and moral implications and risks of sexual behaviour.
- To help all boys and girls accept that both sexes must behave responsibly in sexual matters.
- To develop student self esteem, so that they are more likely to develop caring relationships and are less likely to exploit or be exploited by others.
- To help young people develop the skills, knowledge, understanding and confidence required to make informed choices about their lifestyle so as to promote good health in themselves and others.
- To inform young people about the health and welfare services available and how to use them.
- Our overall aim is to help young people understand themselves as individuals, their sexuality and their relationships with others by equipping them to participate in society as informed, competent, responsible and caring individuals.

Organisation of School Sex and Relationships Education

- Sex education within science will be taught by qualified science staff. The teaching of the six principal religions in Britain with regard to sexual behaviour will be addressed in PRE in Key Stage 3. In years 7 and 8, aspects of sex education regarding self esteem and peer pressure will be delivered within the PSHCE. In years 9, 10 and 11, sex education will be delivered within the PSHCE programme by selected staff. At 6th form level it will be in tutorial by tutors. Outside speakers will be used as and when appropriate.
- Classroom ground rules are set for staff and students to enable all to feel secure. These
 rules do not allow inappropriate personal questions to be asked and emphasise the right to
 be listened to with respect. No student will be asked to do or say anything she/he does
 not feel comfortable about.
- Teaching will include the giving out of factual information, but the importance of open discussion and role play will be recognised.
- A variety of resources will be used as appropriate to the age of the student. The school
 will continue to choose resources which give a balanced view, especially for potentially
 controversial topics such as abortion and LGBT (Lesbian, Gay, Bi-sexual, Transgender).
- It is necessary to be quite explicit in the teaching of some topics (such as contraception
 and the transmission of HIV) but this will be handled sensitively. Some students may ask
 explicit questions and if a response to the whole class does not seem appropriate, the
 question may be answered only to the individual or small group of students. Unless
 otherwise specified in the outline scheme of work, all lessons will be taught in mixed
 gender groups.
- All students are entitled to a programme of sex education. Parents may, however, request
 that their children are withdrawn from some areas. Withdrawal from the National
 Curriculum aspects of sex education is not permitted by law. Parents should also be
 aware that some aspects of sex education arise in subjects other than science (e.g. the
 study of population in the Geography National Curriculum). Questions which arise
 naturally in the classroom will be answered by subject staff.

Moral and Values Framework

Our moral and values framework has been drawn up with reference to government legislation and guidance which affirms the need to encourage students to have due regard to moral considerations and the value of family life.

Key elements of our framework.

- To emphasise the importance of marriage and loving committed partnerships as the ideal context for sexual activity.
- To recognise the nature and importance of stable relationships for family life and bringing up children, with particular reference to marriage.
- To consider the teaching of Christianity and the other principal religions represented in Britain with regard to family life and sexual behaviour.
- To accept the value of all people and the differences in sexual attitudes between cultures.
- To emphasise equality in relationships and responsibility.

- To help young people resist the pressure to become prematurely involved in sexual activity and to present choosing not to have sex as a positive option.
- To teach the current legislation relating to sexual behaviour
- To respond to the challenges that new technologies and trends pose

Sex and Relationships Education Scheme of Work (Outline)

YEAR 7: 4 week module. Tested to Level 6

National Curriculum Science

- Basic facts on puberty building on work done in KS2
- · secondary sexual characteristics
- anatomy
- sexual intercourse
- pregnancy, birth.
- No notes given on Contraceptives or Aids. Questions answered if asked.

PSHCE

Friendships, assertiveness, awareness of peer group pressure.

YEAR 8

- As part of a Drugs Education Morning, pupils take part in a classroom session about resisting peer pressure and also a workshop exploring peer pressure run by a visiting theatre company.
- Topic on Risk and Making Decisions includes a lesson on cyber bullying and "sexting".

YEAR 9: 3 week module

National Curriculum Science

Build on basic facts from Yr 7 by:

- Highlighting adaptions of sex cells, i.e., relating structure/shape of cells to function or fertilisation.
- Go over role of hormones and importance to menstrual cycle, pregnancy etc.
- Discuss/analyse food charts to outline healthy diet for pregnant mother.
- Discuss/analyse figures to show dangers of smoking/drugs during pregnancy.

Health Education (part of PSHCE as a half a term unit)

- Implications of being in a sexual relationship (including LGBT), making sexual health decisions.
- Sexually Transmitted Diseases/Infections (including HIV/AIDS). Where to find advice/help.
- Contraception Recognise common methods and gain basic understanding of how they work. Advantages and disadvantages.

YEAR 10

Health Education (part of PSHCE – run as a collapsed timetable activity day, with input from a visiting theatre company alongside other classroom based activities)

- Alcohol/Drugs education with link to unsafe sex. Where to find advice/help.
- Pregnancy
- Sexually Transmitted Disease
- Contraception.
- Abortions

YEARS 12/13

Through the tutorial system occasional discussions, debates and speakers tackle issues of concern to this age group. We are not prescriptive at this level as to the topics covered, the Head of Sixth Form responds to the needs of the students and issues of national interest. Suitable topics could be, for example, consent, gene therapy, grooming, medical ethics and abortion. The Sixth Form is currently looking at expanding the scope of sexual health provision.

Specific Issues Statement

Teachers will NOT advise individual students on contraception although certain general
information will be presented which may include handling samples of contraceptive
materials. If a teacher feels that it is appropriate for a student to receive some form of
advice/further information on contraception or the student requests such
information/advice, referral will be made to the School Nurse.

- Confidentiality within the classroom cannot always be guaranteed and on occasions it may
 be necessary for information to be brought to the attention of the relevant senior member
 of staff and, if appropriate, to the parents of the students. However, the School Nurse and
 School Counsellor work within a different set of guidelines and can therefore respect
 greater confidentiality.
- On occasions issues might arise within sex education classes which may cause the teacher to have some concerns about child sexual abuse. In such cases the LA guidelines will be followed (see School Child Protection Policy).
- Parents/guardians have the legal right to withdraw their child from all or part of the school's Sex Education Programme with the exception of National Curriculum Science. If parents wish to exercise this right, they should notify the school in writing of their request. Such a request should be made at the beginning of the appropriate year or as soon as possible thereafter so that alternative arrangements can be made.
- Any complaints regarding the Sex Education and Relationships Programme should be made in accordance with the Complaints Procedure for Parents as outlined on the school website.
- Health professionals and visitors will be involved in the delivery of certain parts of the programme. An appropriate member of staff will always be present during these times and will have agreed the content of the lesson with the visitor.

Dissemination of Policy and Working with Parents

- All parents of students at Katherine Warington School will receive a summary of the Sex and Relationships Education Policy.
- The parents of "casual entrants" will receive the summary once a place at the school has been confirmed. In the case of Secondary Transfer students, this will be issued together with other documentation during the summer term prior to transfer.
- A copy of the full policy statement will be available on request.
- If parents have concerns or questions relating to the policy, they are invited to address them direct to the school.

Procedures for Policy Monitoring and Evaluation

The policy will be monitored regularly by the PSHCE Subject Leader and the PSHCE Line Manager, and formally reviewed by the Governing Body every three years.

The following criteria will be used in monitoring the success of the policy:

- verbal feedback from students at the end of work units
- the quality of students' written and oral work
- core skills assessments made by teaching staff for reports.
- feedback from staff via online surveys.
- the number of students withdrawn from sex education and the reasons for withdrawal
- number of parental complaints about the sex education programme
- student self-assessment
